

**THE MARQUEE** Will be available for setting-up from 09.00 – 19.00hrs on Thursday prior to the Show. Any Traders wishing to commence before then must obtain prior permission from the Trade Site Events Administrator. If set up is not possible for a trader until the Friday morning then the trader needs to request this in writing before 31<sup>st</sup> July 2024, and set-up needs to be completed by no later than 08.00hrs.
